Resolutions allow us to focus on getting better, stronger and healthier. Consider including these five resolutions to your list of promises for the New Year:

RESOLVE to effect a change in your company's paradigm. Take a moment to sit down and visit the past in order to envision the future. What has worked? What has not? Who are your company's biggest clients? Have you personally thanked them for their business? Have you asked them what you could do better? Resolve to reduce the customer complaints this year and, if necessary, promptly address and learn from complaints received in the past to ensure that the same complaints are not repeated.

In conclusion, each year brings new challenges. Not every challenge can be met from within. As you focus on 2016, looking back on 2015, resolve to get help when you need it.
